KNOW ALL MEN BY THESE PRESENTS, that we, _____,

firmly bound to the Attorney General of the State of New York and any other person who may have a cause of action or claim against the Principal for any malfeasance or misfeasance in the conduct of a solicitation by the Principal as a Professional Fund Raiser, in the sum of \$10,000, to be paid to the Attorney General of the State of New York or to any other person who may have a cause of action or claim against the Principal for any malfeasance or misfeasance in the conduct of a solicitation by the Principal as a Professional Fund Raiser, and that we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, by this bond.

WHEREAS, the Principal has applied to the Attorney General of the State of New York for registration as a Professional Fund Raiser pursuant to Article 7-A of the Executive Law of the State of New York;

NOW, therefore, the terms of this obligation shall be:

That if the Principal shall register with the Attorney General of the State of New York as a Professional Fund Raiser and if the Principal shall faithfully and honestly act in accordance with the law, and if the Principal shall fully comply with the provisions of Article 7-A of the Executive Law of the State of New York, and if the Principal shall fully indemnify and save harmless from loss the State of New York and any person who may have a cause of action or claim against the Principal for any malfeasance or misfeasance in the conduct of solicitation as such Professional Fund Raiser, then this obligation shall be void, otherwise it shall remain in full force and effect.

In addition, this bond shall not become void upon the first recovery thereon but may be sued upon from time to time until the full amount thereof shall have been exhausted.

This bond shall cover any cause of action or claim arising on account of the Principal's action as a Professional Fund Raiser for a period beginning on _____, _____, which shall be deemed the date of the Principal's registration with the Attorney General, and ending exactly one year from that date, which shall be deemed the expiration date of the Principal's annual registration, pursuant to §17 3.1 of Article 7-A of the Executive Law of the State of New York; provided, however, the Principal and the Surety shall be liable, to the extent of the bond, for any such cause of action or claim notice of which is presented to the Principal or to the Surety.
