- The form shall be typed and be signed by responsible individuals who have an correct knowledge of the facts and the authority to bind the applicant.

This bond shall be further subject to the following conditions:

- The bond shall be continuous and shall remain in force until the Surety is released from liability by the Department of Environmental Conservation of the State of New York, or until the bond is canceled by the Surety as herein provided. Without prejudice to any liability incurred prior to such cancellation, the Surety may cancel this bond upon ninety (90) days advance notice in writing sent by mail to the Principal and to the Department of Environmental Conservation of the State of New York.

\_\_\_\_\_ shall the total liability of the Surety for any one or more recoveries under this bond exceed in the aggregate the amount of this bond. Any claim upon this bond must be instituted before the expiration of two years after the release, cancellation or expiration of this bond.
