This project includes line painting & painting of handicapped parking symbols and loading area/crosswalk designations in all parking areas. All oil spots shall be cleaned prior to seal coating.

For A Partnership in Housing, Inc., this project involves undertaking asphalt driveway and parking area cleaning, crack repair and seal coating at 2 locations in Smethport, 2 in Mt. Jewett and 1 in Kane. This project includes line painting & painting of handicapped parking symbols and loading area/crosswalk designations in all parking areas. All oil spots shall be cleaned prior to seal coating.

This project shall be undertaken in accordance with the General and Technical Specifications and the project contract.

2. - 4. In no instance shall a Subcontractor perform any work on the project until the Prime Contractor has provided the Owner with the Subcontractor's insurance certificate and Non-Collusion Affidavit.
- 5. If Subcontractor is an "owner-operator" without Workmen's Compensation, the Prime Contractor shall add the Subcontractor to his/her Workmen's Compensation Insurance. Under no circumstances is anyone to work on this project without Workmen's Compensation Insurance.
- 6. Prime Contractors shall provide weekly payroll reporting forms for all Subcontractor owner-operators to insure that they are being paid the required prevailing wage rate.
- 7. Subcontractors with employees shall submit weekly payroll reporting forms to the Prime Contractor. The Prime Contractor shall then submit the Subcontractor's payroll reporting forms to the McKean County Redevelopment Authority.
- 8. Subcontractors are bound by the same reporting requirements as the Prime Contractor (i.e. WBE/MBE, Section 3, Prevailing Wage, etc.).
